## KIT AND EQUIPMENT

I understand that the training kit, match kit and tracksuit are on loan for the duration of my membership with Maidstone United Raiders and I will look after it and keep it in good condition.

- Kit must only be washed at 40 degrees and not ironed or tumble dried as the logos come off.***

If I should leave the club, all kit will be returned to Lorraine Humm in a clean and good condition or I will be liable for paying for a replacement. All kit, when not worn, should be put in a bag or stored safely.

It is the responsibility of the borrower to keep kit items safe, so no other player takes in error or it is left at a venue. The kit is only to be worn to training and matches, not personnel use. Players will be liable to replace missing any missing kit items.

## WELFARE

If I have any concerns throughout the season, I will follow the club process for resolving these by speaking to the Team Manager, Head of Section or Club Welfare Officer.

If an adult player is cautioned or sent off in a match, they will be liable to pay the fine. These range from £10 to £125 in extreme cases of violent conduct.

A junior player's parent/guardian will be asked to pay for any fines their child incurs from the Kent FA. Raiders is a non-profit making section of the club.
